



## Online Privacy Policy

### Collection of Personally Identifiable Information

### Disclosure of Information to Third Parties

The exception to this is In the event that we undergo reorganization or are sold to a third party, any PII that we hold may be transferred to such reorganized entity or third party for the purposes of and subject to the terms of this Online Privacy Policy . Welltrain may use subcontractors for purposes of server maintenance or information storage. Any such subcontractors will be subject to the same security and confidentiality standards as Welltrain.

Please note that Welltrain may also be obliged to disclose your personal information to meet any legal or regulatory requirements or obligations in accordance with applicable law.



## Cookies

We may use cookies to record certain general registration details on your hard drive. Cookies are small bits of information that an Internet site places on the hard drive of your computer to record general information about your activities on that site.
